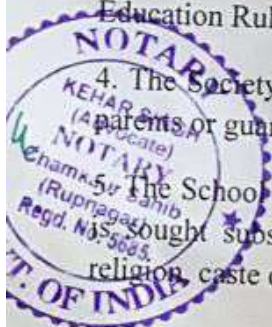

6. The School shall ensure:

I. No child admitted shall be held back in any class or expelled from school till the completion of elementary education in the school.

II. No child shall be subjected to physical punishment or mental harassment.

III. No child is required to pass any board examination till the completion of elementary education.

IV. Every child completing elementary education shall be awarded a certificate as laid down under Rule 23.

V. Inclusion of Students with disabilities/special needs as per provision of the Act.

VI. The teachers are recruited with minimum qualification as laid under section 23(1) of the Act. Provided further that the current teachers who, at the commencement of this Act do not possess minimum qualification shall acquire such minimum qualifications within a period of 5 years.

VII. The teacher performs its duties specified under section 24(1) of the Act and

7. The School shall follow the syllabus on the basis of curriculum laid down by appropriate authority.

8. No unrecognized his/her shall run within the premises of the school or outside in the same name of school.

9. The school buildings or other structures or the grounds are used only for the purpose education and skill development.

10. The School is run by a society registered under the Societies Registration Act, 1860 (21 of 1960), or a public trust constituted under any law for the time being in force.

11. The School is not run for profit to any individual, group or association of individuals or any other persons.

12. The accounts should be audited and certified by a Chartered Accountant and proper accounts statements should be prepared as per rule. A copy each of the Statements of Accounts should be sent to the DEO every year.

13. The school furnishes such reports and information as may be required by the Director of Education/District Education Officer from time to time and complies with such instruction of the State Government/ Local Authority as may be issued to secure the continued fulfillment of the condition of recognition or the removal of deficiencies in working of the school:

14. Renewal of Registration of Society if any, be ensured. Other conditions as per Annexure III enclosed.
